WFWO TEAM FUNCTIONS AND RESPONSIBILITIES

➤ **The Executive President (EP) & Board Members (BM)**

World For World Organization (WFWO) is governed by the Executive President, with permanent support of the Secretary General and voluntary basis contributions from Executive Board Members and Members.

The Executive President, is responsible for ensuring the resource mobilizations as well managed in line with its vision and mission, and its objectives of the Organizations.

WFWO Board Members currently who all give up their time and energy voluntarily to ensure that WFWO is compliant with the legal and statutory requirements ?

The WFWO Executive President (EP) has review the achievements works of the Organization and results in 2003/5. The EP and Board decided to reduce the size of the Board Member, and recruit through an open selection process to ensure that we have the professional skills and experience needed for WFWO to operate effectively to achieve its objectives.

While retaining representation from the advocacy networks mission that, reflecting, to AND - FFWW, we actively encourage people with international development experience, in developed country, and in particularly in developing countries : Africa, Asia, Europe, North America and Latin America, to be candidate and selected in the country representatives, or operations mission where is required. We will also continue to strive our straighten support on focusing in diverse and gender balanced, to help people to work in their country representatives, as wells as to save funds to the WFWO, with this saving funds can be also utilized for project components, or other activities for the project.

➤ **The Executive President (EP)**

The Executive President, is responsible for managing the hall organization, along with the support of Team Coordinators of the following Divisions Teams:

➤ **Operations Team (OT)**

The Operations Team is split into five teams - The Program Support Team including the External Evaluations Team and Expert Field Consultants, and four others that each manager the programs of a specific region: Africa, Asia, Eastern Europe, Latin America the Country offices are led by Country

Representatives who manage the country programs in accordance with the strategies and policy of the WFWO, developed with the Regional Coordinator's.

The External Evaluations Team, is responsible to evaluate every year WFWO project as per WFWO policy & strategy & guidelines.

The Expert Filed Consultants, is responsible for project design and cycle or preparation of the project, under general Coordination of Operations Team – The Expert Filed Consultant, is recruited only for operations mission, in specific areas of expertise of he/she.

As concerning the voluntary purpose the WFWO, will cover only expenses and per-diem and logical support in country where the mission is proposed, this will save to WFWO funds, to be utilized for other components of the project.

➤ **Policy and Strategy Team (PST)**

The Policy and Strategy Team ,is responsible for WFWO’s advocacy, research and guidelines, to achieve its objectives, in the areas of : Projects, partnerships, and at all levels, including: governments, international organizations, NGO, private sector, advocacy activities focusing on promoting good practice in the areas that in the interest of the WFWO activities and objectives, in order to raise awareness, and to achieve the WFWO aims.

➤ **Planning and Strategy Team (PST)**

The Planning and Strategy Team, is responsible for WFWO’s lending programs and strategy, and plan events and program, as per WFWO strategy and planing programs of the WFWO at all levels nationally and internationally.

➤ **Legal Advisers Team (LAT)**

The legal Advisers Team is responsible for any legal aspect of the WFWO, activities at all levels nationally and internationally, and for any agreements and grants and negotiations related the WFWO operations and administration matters.

➤ **Regional Resource Mobilizations Team (RRMT)**

The Regional Resource Mobilizations Team, is responsible for all resource mobilizations, by region and country representatives, and is working under direction of the EP, and close cooperation with WFWO Operations Team, The RMT has important role to play at all levels, nationally and internationally in relations with governments, Private sector, foundation, financial institutions and other potential sponsors, to support the WFWO Humanitarian projects worldwide and its activities.

➤ **WFWO Advocacy Networks–Ambassador for Development (ADN)**

The ADN Network, is responsible and focus on development issues and public awareness and resources mobilizations to support the WFWO activities , in the country representatives, and to promote the Millennium Development Goals MDG’s.

➤ **WFWO Advocacy Network -WFW Friends Networks (FWFW)**

The FWFW Network, is responsible and focus on development issues and public awareness to support the WFWO activities, and to plan events and fundraising activities to promote the Millennium Development Goals MDG's.

➤ **Communications Team (CT)**

The Communications Team , is Coordinate the following Teams:

The Communications Team, is coordinating the following activities: Fundraising, Special Events Media, Audiovisual, and Publications Team. The main activities of the Communications Team , is to promotes WFWO's activities to various audiences, in order to generate funds for its projects and public awareness and Humanitarian projects, and global issue around the world. The Communication is also responsible of the corporate image of the Organization.

The Media team promotes events , and deals with media enquiries locally and internationally.

➤ **General Affairs Team (GAT)**

The General Affairs, is Coordinate the following Teams:

Finance Team and Audit Committee (FTAC)

The Finance Department deals with the organization's accounting, and administration needs. WFWO is committed to stringent auditing procedures, so an internal auditor is employed to oversee the accounting procedures of each of the country programs, in addition to external auditors.

Administration and Human Resources (AHRT)

The Administration and Human Resources Team at WFWO, looks after all of the issues relating to Administration, and WFWO activities at all levels.

The partnership Team ,is responsible for any relations related to partnerships with : government , financial institutions , private sector, NGO, local communities,; or other organization working in the areas of the interests of the WFWO activities and objectives, at all levels nationally and internationally.
